## Changes to the definition of a “Dealing Day” for Vanguard’s UK funds – no action required

We are writing to inform you of certain changes we are making to our UK-based funds (the “Funds”). You are receiving this letter because you are an investor in one or more of the Funds. This letter is important and requires your attention but you do not need to take any action.

### What are we changing?

We are making changes to the definitions of a “dealing day” in the prospectuses for the Funds. Dealing days are days on which you can buy, sell or exchange your units (or shares), and are usually days on which the London Stock Exchange is open for trading. However, other days can also be treated as non-dealing days under certain circumstances. This will usually be when it is difficult for us to buy or sell investments for the Funds or to value the investments held by the Funds. Examples of this are where a stock exchange in a market where a Fund makes significant investments is closed or there is a public holiday in a country where the investment adviser or one of its delegates are based) or, for funds that invest in other funds, where the underlying funds are closed.

Following the changes, there will be more flexibility to declare non-dealing days under certain circumstances, but in practice we do not expect the number of non-dealing days to change significantly as a result of the changes. You will be able to find the Fund Holiday Calendar on our website in the same way that you can now.

Details of the changes we are making for each of the prospectuses for the Funds are set out in the Appendix.

### When will the changes take place?

The changes set out above will take effect from 22 May 2023. Updated prospectuses for the Funds will be published on or around that date to reflect the changes. We will continue to publish the Fund Holiday Calendar showing the non-dealing days on our website at <https://global.vanguard.com/portal/site/loadPDF?country=global&docId=11627>.
